The appellant is disputing an increase to her Council Tax liability for the period 27.07.2015 to 09.04.2018, caused by the re-calculation of her Council Tax Reduction for the period. Earnings and Childcare proofs were received showing a significant change in the Appellant's income and outgoings which resulted in multiple assessments changing the amount of Council Tax Reduction Applied.

Section 2 - The Appellant's case

The Appellant disputes the Council Tax Bill for the period 27.07.2015 to 09.04.2018, the net adjustment to the discount is \pounds -1130.88 amended by the Respondent over the period 06.06.2019 to 22.11.2019. The Appellant states that she was not aware the incorrect figures were used in her award and that she had provided the Respondent with the correct figures that were input incorrectly.

Customer received Single Person Discount during the period in Question.

Your awards for Housing Benefit and Local Council Tax Support have been reviewed.

The reason for this review is because you have provided Wage slips. Tax credit award notifications, proof of Child maintenance, you have also have informed me that you no longer have child care. Prior to the information received from the Department of Works and Pension on the 6th June 2019 the previous information we had received regarding your earnings was wage slips dated the 28.6.2015 and 28.5.2015. Which showed monthly wages of £502.94 and £449.31.

The information supplied by the Department of Works and Pension are wage slips for Kings Church Loughborough dated the 28.6.2018 to 26.10.2018 and Castle View Nursery Ltd wage slips dated the 5.11.2018 to the 5.6.2019.

The wage slips you have supplied confirm the Details we have received from the Department of Works and Pension. The Tax Credits you have provided are the same as the information we have received from the HMRC.

I have looked again at my decision dated the 6th June 2019 and looked at the information you have provided I have made the following amendments. As you have supplied your wage slip 28.7.2017 I have used the gross to date on this wage slip from the 1.4.2017 and have calculated your wages from this date at £683.31 per month as follows:

Your awards for Housing Benefit and Local Council Tax Support have been reviewed.

Thank you for your email received 19.08.2019. You have requested an appeal of the decisions dated 06.06.2019 and 01.08.2019. These overpayments occurred due to a change in your earnings that you failed to notify me of. The decisions occurred as follows;

06.06.2019 – Your claim was being assessed based on the wage slips dated 26.06.2015 and 28.05.2015 which were received on the 21.07.2015, this calculated your average weekly earnings to £109.88. You received letters dated the 24.08.2015, 21.10.2016, 09.12.2016, 14.12.2016, 04.05.2017, 06.07.2017, 03.05.2018, 14.05.2018, 29.05.2018 and 30.04.2019 stating this was the earnings being used in your assessment, all these letters state

'It is very important that you check the details in this letter and let us know if any are incorrect.'

I then received a file from Verify earnings and pension that advised me you had changed employers in October 2018 but had failed to notify me. Your claim was assessed on the 06.06.2019 for the period 04.06.2018 to 03.06.2019 as follows;

- 04.06.2018 to 03.09.2018 using an average of your June, July and August 2018 wage slips showing your average weekly earnings at £167.82 per week which is a £57.94 per week earning increase that I was not aware of.

- 03.09.2018 to 08.10.2018 your October wage slip was used showing your weekly earnings at £194.42 per week, which is an £84.54 per week/ £366.34 per month increase on the 2015 wage slips you had provided.

- 29.10.2018 – 06.05.2019 your earnings were amended to reflect the change in your employment. I note the wages received on the 05.05.2019 must be input for the month of April that they cover. I have amended this.

- 01.08.2019 – I received a letter from you on the 18.06.2019 asking me to look again at the decision dated the 06.06.2019, in this letter you stated your earnings increase was in line with minimum pay rise, as per the explanation above this is not the case it was a significant increase in your income and a change in employment which you failed to notify me of. You also provided your 2018 P60 which showed that from April 2017 your earnings were higher than the wage slips dated 26.06.2015 and 28.05.2015 wage slip being used in your assessment and that you no longer paid Childcare but had failed to notify me. You claim has therefore been assessed as follows

- 03.04.2017 – 02.04.2018 – your claim is amended using your July 2017 wage slip, however your 2018 P60 shows a slightly lower figure so I have amended this and reduced the overpayment dated the 01.08.2019 by £30.78.

- 02.04.2018 – 03.06.2018 – your earnings were amended to reflect the pay slips you provided.

- 02.04.2018 – I also removed the childcare cost that was loaded on your claim and was detailed in all your award letters as above.

- The remaining payslips you provided showed the same amount I had used when assessing your claim on the 06.06.2019.

- On the 02.07.2019 you provided your June wage slip showing a decrease in your earnings and your claim was amended to reflect this from the 03.06.2019 and your July wage slip is being used going forward and you must notify me of any changes to your income or circumstances.

If you wish to continue with an appeal please provide the following information I will address each issue you have raised in your email

- No errors were made by my department

- The award has been done on DWP figures, however the DWP figures are information I receive regarding your Tax Credits as indicated in the letters, this does not tell me about any earnings.

- Your wage increases exceed the national minimum wage increases however even if they didn't it is still your responsibility to report all changes of circumstances to the Local Authority.

- I accept you have now provided all the information regarding the past changes in your circumstances however this does not mean the overpayment is not recoverable from you.

- It is your responsibility to notify of a change in your income and not a requirement that Charnwood Borough Benefits write to all benefit recipients asking them if they have had any changes in their circumstances.

- Your wage slips other than for the period 17/18 when your P60 has been used have been loaded as monthly figures for the period they cover.

- You state you were advised in a call that you were advised that the LA no longer automatically input minimum wage increases, however your new contract is paid at above the minimum wage and it is a claimant's responsibility to notify of all changes in their income.

- Unfortunately Charnwood is not able to take action against employers who do not pay the minimum wage however I would encourage any person in this situation to contact HMR&C to report the employer.

- Your Tax Credit award letter have advised you that if you are in receipt of Housing Benefit you must notify the Local Authority of your changes, however all the letters issued to you advise you to check the income used in your claim and notify the LA if it is incorrect, you have never notified me that it was incorrect for both your earnings and childcare costs.

Please note all the letters issued to you state that

'You must tell the Benefit Section at Charnwood Borough Council, in writing, within 21 days, of any change that may affect your entitlement to Local Council Tax Support and within one calendar month of any change that only affects entitlement to Housing Benefit.

Some examples of changes that we will need to know about include:

increases in your or your partner's income/savings, if someone leaves or joins your household, and any changes in the amount of rent you pay. You may lose entitlement if you do not tell us within these timeframes. If you receive more Local Council Tax Support or have an overpayment of Housing Benefit because you did not tell us about any changes straightaway you will be sent a revised bill for Council Tax and an invoice for Housing Benefit which you will have to pay.

As a benefit claimant it is not your responsibility to decide what should be reported and what should not, any changes in your income be it increase due to minimum wage or a change in a job must be reported.

Dear xxxx,

I refer to your email of 16th August 2019 stating that you wish to appeal against the Council's decisions about your housing benefit and disputing your Council Tax Support award on the same grounds.

I appreciate this letter includes a lot of information, if having read it you would like clarification or to discuss any of the details please telephone 01509 634858 and ask for my Appeals Officer, Cheryl Higgins.

To recap - on 18th June 2019 you asked for a revision of the Council's decision dated 6th June 2019. The decision was revised on 1st August 2019 but not favourably. On 16th August 2019 you appealed against the revised decision it was again revised on 6th September 2019 but again not favourably and you confirmed that you wished to continue your appeal to a tribunal.

Whenever I receive an appeal all the details of the case are checked to see if there are grounds to change the decision. I'm afraid I found no grounds to change the appealed decision favourably. However I have made the following changes:

1. As you had explained that did not have any child care costs I have removed them from the assessment of your entitlement from the date they had been included which was from 7th September 2019.

2. I have also corrected your earnings for the period 29th October 2018 to 1st April 2019 as a £0.97pw deduction for National Insurance had incorrectly been included.

3. I have amended your child maintenance to £114.04 from 14th May 2019 as I understand from the review letter your provided this was the weekly liability from 11th May 2019. This doesn't affect your entitlement as the full amount is disregarded when assessing Housing Benefit and Council tax support.

You will see that I haven't changed the amount of capital that is listed on the calculation pages as $\pounds 283.74$ in a santander account **2481. Provided you have capital of under $\pounds 6000.00$ it has no effect on the calculation of your entitlement. If you have closed the santander account and would like the capital listed updated please supply evidence of the amount you hold and the account it is held in.

Good Morning,

Apologies for yet another email but I really would like this situation resolving asap.

So far I have sent two letters explaining fully why I think the overpayments before April 2019 should be overturned and if this is not agreeable by yourselves request it be sent to Tribunal.

However for this financial year now the problem has been highlighted obviously want my award to be correct.

I have pointed out that I still believe your calculations to be incorrect and have provided what I believe are the correct weekly income figures for myself in a previous letter and I have asked for this to be looked into and recalculated.

This morning I received yet another letter dated 7th August and the figures for my weekly income are still incorrect.

I have also pointed out how complicated and hard to understand I find your figures as they do not tally with my weekly income and ask that in this case you use a more simple way of explaining and showing the calculations.

Below I have enclosed an example of how I think it would be easy to show the calculations.

The figures are obviously examples as it needs to be recalculated but using these charts I can clearly see that an overpayment in housing benefit has been made and would be in credit for

Council Tax again only examples and aware a credit for council tax may not be the case once the awards have been correctly calculated.

I have ran my own business in the past and managed financial accounts for that business and also worked for the Tribunal Service for 10 years and in that time worked in the finance department for judicial claims so usually have a fairly good understanding of figures yet find yours completely confusing and no idea how you reach them.

If I have a fairly good understanding of figures and accounts but find your methods complicated and confusing for others it must be even more daunting.

The amount of stress this whole situation is causing me is absolutely ridiculous.

Please can my award from April 2019 be recalculated and shown in a way that is understandable like the spreadsheets attached. I would like this resolving as soon

as possible so I know where I am financially and to relieve the current stress that all this is causing

Dear Mr Mark Bennett,

Thank You for your letter dated 18th November 2019 explaining that now the error missing off the single person discount since December 2016 has been amended it has had an even further effect on the amount of council tax support that I am entitled to and increased my council tax balance by £957.46 however my online account shows £773.06 outstanding and the bills dated 19th November 2019 that arrived today with your letter add up to £636.95. Firstly, I am unsure which of the three figures is correct and what I actually owe? It is very confusing to me.

Secondly on your calculations I see that it still has the Santander Account and £283.74 net capital showing. I now know that this has no effect on the award amount but I did ask for this to be amended in June as I do not have this account and haven't for many years and when you wrote to me in October you advised me to get it removed I needed to send you a copy of my current bank statement which I did, yet Santander is still showing.

Also, I have provided all my financial information to you in June and submitted my 2016/17 wage slips as requested and I can still not get my weekly income figures to match most of your figures. I was told that you used my monthly wage slip x 12 / 52 I have used that method and only match with your figures for 3 September 2018 – 8th October page 17 of you letter, however that figure should only be to the end of September and not include the first week of October. I also agree with your figures on Page 25 -30. I have a listed the figures I can't get to match and the page number of your letter.

Page 4 you have the amount as £109.88 yet using my p60 divided by 52 like you have for the 2017 figures I get £149.33 using my monthly wage slips I get Dec'16-£144.00, Jan'17-£153.97, Feb'17-£144.00 and Mar'17 £152.31.None of these match the figure you have used.

Page 6 you have used my P60 and used the same weekly figure for the whole year and you get £157.38 and I get £157.37. As you have used this method for this financial year confused as to why you haven't used this method for all years or used monthly wage slips for all years. Using two different methods again makes all this very confusing.

Page 11 using the P60 for 2018-2019 I get the weekly figure to be £163.40 but your figures show £170.12. I used my April 2018 wage slip and get the amount to be £166.50 again not matching the one you have used this applies also for page 12 of your letter.

Page 13 &14 you have the weekly figure as £170.12 for May, unfortunately I do not have the wage slip to check this as I have misplaced it.

Page 15 & 16 covers 4th June to 3 September 2018 and you use the figure £168.61 and 0.79 national insurance. Using my June wage slip I get £169.22 and 0.54 national insurance. July's wage slip is missing but August I get £166.50.

Page 18 you have my weekly figure as £168.61. I worked for Small World Nursery up to the 12^{th} October and had half term week off as I am term time only before starting at Castle View on 22^{nd} October. Half term will have been covered in the Small World Wage slip I am guessing as my wages are spread across the year to cover holidays and will have been owed pay for previous hours worked/holiday entitlement in that wage slip. Adding the two wage slips together I get my weekly figure to be £170.40 and separately using the x 12 / 52 method get Small world to be £106.71 and £63.69 for Castle View. If the Small World wage slip was divided by two to cover the two weeks worked that month I get £231.21 and if it is by three to cover the half term week get £154.13 again none of these figure match yours.

Page 19 you have from 15th October – 29th October as no weekly income at all. My half term should be covered in the wage slip from Small World and if not, I started working at Castle View on 22nd October so only one week with no income.

Page 20 you have from 29th October 2018- 1st April 2019 with my weekly income as £149.12. Using the P60 method I get £163.40. Using my wage slips I get Nov & Dec '18- £150.74, Jan'19 £153.45, Feb'19 £150.74 and March '19 - £139.90 again not matching your figures.

Page 21-22 April 1st – 6th May'19 your figure is £165.14 but using April's wage slip I get £162.78

Page 23-24 6th May- 3rd June your figure is again £165.14 but using May's wage slip I get £167.30

On page 31 you have based figures on my latest payslip and have the figure ± 106.87 but I get ± 109.67 .

Also, in your calculations it shows different amounts for my tax credits but as far as I am aware, I get the same figure every four weeks for the whole year.

I have submitted my calculations to you previously and had no response as to how you get your figures but I have used the method I was told you used by your colleague Sarah Wilson so can't understand why half of them are different.

I agree that there has been an error calculating my award and that there will be an outstanding amount for previous years, however this is down to an error in your department not paying due care and attention when processing my award. This has not been through any fault of my own. I trusted the bills issued to me at the time to be correct and paid them in full. I have never been behind with my council tax in the 18 years I have been paying it. Only the last six have been single occupancy and the last four had further support.

As the errors where made by the department when calculating my award feel it unfair that I am now left with a huge bill from previous years.

Even if you did use the figures that I believe are correct to calculate the award and I completely agree with the calculations it does not change the fact that this error is your mistake and not mine and therefore wish for it to go to Tribunal either alongside the Housing Benefit Tribunal or to the separate Valuation Tribunal if that is the correct process.

This based on: -

Department error not applying 25% single person discount from December 2016- November 2019. When I raised my concern that I was unsure if it had been added or not was told to submit a new claim online which I did to be told some weeks later that they were unable to locate the online application I did forward the confirmation email I got with the reference number. I then had to print and sign a copy before it to be actioned as the online one went missing. Another department error.

I still can't get my weekly income figures to match yours no matter what I try- complicated and confusing. If my any of my figures are correct, then award is still incorrect.

I gave you all my information in June and it has been recalculated at least three/four times since again showing further errors have been made calculating my award even when provided with all my financial information

This overpayment has occurred due to you calculating my award on two payslips from 2015. The letters you sent with my award amount do not state minimum wage increases are not taken into

account which is all I had received up until I was promoted 29th April 2019. I thought they had been taken into account automatically and that my award was correct. When I spoke to your colleague in August, I was told it was taken into account but then you stopped. Again, your letters do not make that situation clear. When I was promoted April 2019 the first full wage slip I received at this rate was paid to me on 5th June 2019 and you were notified of this in my letter dated 16th June so within the 21 days that you request on the award letters.

I did not notify you of my change of employer in October 2018 as this was not a beneficial change as I was working two hours a week less and my wages went down. I thought only beneficial changes needed reporting and apologise if this was incorrect and have previously apologised for this.

My award letters said based on Tax Credit Figures which are correct. I thought you had all the relevant information you needed and had no idea that you had still been calculating my award based on a wage slip four years old and that errors had been made.

I have been completely transparent and provided anything requested of me and I submitted all the financial information I had to you in June convinced you had all the information you required, and it must be a mistake. Since you explained how this error occurred I now agree an overpayment has been made but I have spent hours trying to understand and match the figures you use and still have no idea where half the figures you used have come from.

The stress this situation has caused me and my family has been incredible and I wish to proceed to tribunal as soon as possible as this hanging over me is hindering my recovery and full return to work and causing tremendous amounts of stress as my award is recalculated and amended all the time I have no idea where I am finically from one minute to the next.

As I feel this outstanding amount whatever the figure maybe has arisen due to you not paying due care and attention when processing my claim and not my error that caused this situation request that until this has been heard by Tribunal that no requests for payments are made.

I will make payments from January 2020 to clear this financial year as the bill dated 19th November states and if an independent tribunal finds I am liable for the previous years will then arrange to make affordable monthly payments to clear the outstanding amount once the appeal has been heard.

I hope that this can proceed to Tribunal as soon as possible as this situation has been ongoing since June this year and I really do not know how much more of this I can take and wish for it to be resolved urgently

Thank you for your email yesterday but after our zoom meeting I reread the decision notice and I have written to the judge asking for direction to clarify what is included in the decision and will wait for his response .

In the meantime can you please provide me with the new figures mentioned yesterday for my records? I know you mentioned they had been calculated again and show I would now owe the department but you didn't mention how much? I also am not sure if this is because the recoverable amount from April 2019 rose from £960.98 that you mentioned in your email dated 18/9 or if it is because the calculations now show less than the £1028.60 that you mentioned had already been recovered? If I could have these figures for my records I would be grateful. With a list of the amounts recovered from my benefit and when? I tried to write down the figures you gave during the call but to be honest the decision notice threw me and I wasn't prepared for all the new information you gave to me and felt overwhelmed with it all.

Having read the notice again it clearly states in paragraph 5 ALL overpayments are down to the department error apart from any that occurred after my pay rise on 29th April 2019 due to my promotion and that I had already taken responsibility for this and repaid it.

Hence why I have written to the judge to clarify if this does included invoices for the 6.6.19, 1.8.19 and 30.9.19 as well as 22.11.19 as I believe or if it only covers the final invoice 22.11.19 as you believe and could go to appeal again.

Apologies this is still ongoing but hopefully the judge can clarify and give us direction as I clearly don't understand your figures still and we now disagree on what is meant in the decision notice too.

I am hoping he can get this resolved fully for us both .

I have also attached the additional evidence for the Valuation Tribunal should that go to hearing, please can I also have a copy of the amounts paid in council tax since July 2015 as my records show I have paid £150.31 more than your records show. I also have seen on the invoice April 2016-December 2017 there is a refund for £177.55 can someone explain to me what this is? I have checked my accounts and can not find any refund being paid to myself for this amount.

I look forward to this all being resolved as soon as possible. Thank you for your time trying to get it all sorted it has been a nightmare situation but I still fully believe this is all down to department error and not my own. It has caused so much stress and anxiety as nothing ever tally's and adjustments are made constantly with no evidence as to where the figures come from or valid explanation as to why they don't match your online figures. This should be clear and easy for a claimant to follow and they aren't and it isn't fair how can a claimant know if figures are correct if they are impossible to understand and different to what their online account shows?

Had my award been calculated correctly in the first place this would not have happened and as it is only their errors that have caused these additions to my bills feel that they should be responsible for them and not myself. I have enclosed a spreadsheet that shows the original bills add up to £ 1315.54 and my records show since July 2015 I have paid £2965.78 therefore request the difference of £1651.24 be returned to myself.

I have requested a copy of latest bills from the council and a record of my payments that have recorded so I can check these figures tally at the moment there is a refunded mentioned on bill for 01/04/2016-13/12/2016 that I have no record of receiving that has been added to the bill for some reason and according to the amount I still owe according to the council and what I believe is still owed there is a difference of £150.31 and I am unsure why.

Further Evidence for Council Tax Support Valuation Tribunal VT00000923

I am appealing the decision regarding my council tax support. In June 2019 Charnwood Borough Council wrote to me as they had identified a problem with my housing benefit award they had miscalculated the award which had resulted in overpayment. This later then highlighted that they had actually miscalculated my award from the very beginning in July 2015.

Since June 2019 the award has been recalculated several times it was these recalculations that has seen my council tax support also adjusted.

In May 2020 I won the appeal against the housing benefit overpayment and a judge decided that I had not contributed to the miscalculations and it was due to department error. As I have won this appeal and it has been agreed it is due to department error surely they are also responsible for shortfall in council tax and not myself.

Their error calculating my award has seen me face huge bill increases, this has caused me so much stress and anxiety. I have faced constant battles with them as their own figures online did not tally with the figures they sent to me by email and letter causing even more confusion and upset. I have found this to be the case with my council tax too and the records I have for the amount paid so far does not match the amount they say is still owed. I have requested a copy of their records so I can identify where the discrepancy is but not yet had a response.

I have put together a spreadsheet with all financial information to be submitted as further evidence, along with all the council tax bills issued, payment agreement information, tribunal decision letter and have asked that they also submit the appeal papers for the housing benefit tribunal as it was that issue that has resulted in this one and the two are directly linked.

I am asking the Tribunal to look at all my evidence that shows this has all been down to the Housing Benefit Departments numerous errors, I have highlighted that their records are not consistent and do not tally. Today on a Zoom call regarding the Housing Benefit Tribunal I was trying to resolve an issue with what money should be returned to me as a result of winning the Tribunal their online figures showing £1434-70 had been recovered and an email sent said only £1028.60 had been recovered meaning only £67.62 was owed to me rather than the £473.72 the online figures showed and today on the zoom call was told they had again recalculated and now I owed them and I wasn't even owed £67.62 but rather than asking for money from myself would but the balance to nil so it did not have to go back to court again. I was only told that I would owe them I was not given the amount their new calculations now showed.

I know that this has nothing to do with the council tax support element but it does support that they are incapable of calculating my award correctly and as it is their constant errors that has caused this so why should I be the one left struggling as it has completely drained me emotionally and

financially as I have been paying towards their error since July 2019 and have paid back £2049.27 in council tax so far on top of this years council tax bill. I have completely lost faith in their ability to calculate my award and when I asked why online figures don't match I was told the online portal isn't very accurate and doesn't show amendments made behind the scenes. I can not understand why their figures do not tally and find it truly disturbing one that they don't tally and two they couldn't give me factual figures as to why they were different and what these behind the scenes adjustments had been.

With this in mind I hope that the original bills are reinstated and the amount recovered towards the adjustment bills returned to me a sum of £1651.24

DECISION NOTICE

1. This hearing took place in the morning of 26 May 2020 by telephone.

 attended, unrepresented and unaccompanied. There was no appearance from the Respondent who had not made contact with the Tribunal to indicate whether or not they wished to attend nor to provide a contact number.

- 3. The Tribunal heard detailed oral evidence from Mrs Lund.
- 4. The decision of the Tribunal is to allow the appeal. We find that the most recent overpayment identified in the final revising decision of 22 November 2019 arose due to official error. The official error is as follows:-
 - When dirst made a claim, the Authority failed to undertake any further checks regarding her income level (this point appears to be accepted by the Authority in any event).
 - ii. gave a figure that she was paying as at the date of claim in respect of child care and then provided the information as to the likely cost of child care from September onwards when her children were due to change schools. The figures are different. At no point did the Authority query this.
 - iii. The Authority was clearly in received of relevant information from HMRC because over time received several communications from the Authority indicating that there had been

a change in her award due to new information received from HMRC.

did not contribute to the overpayment as she simply supplied information to the Authority that she was asked to provide.

Having concluded that the overpayments all arose due to official error to did not contribute, the Tribunal then had to consider 5which should have realised that there was an overpayment. whether had no previous experience of the Housing benefit system and when she first made a claim she went into the council offices and was told to make a claim on-line and to submit documentation which she did. The notes that she was provided with told her to report appropriate changes of circumstances. As she received communications on a regular basis from the Authority confirming that her Housing Benefit award had been varied due to information received from HMRC, she reasonably believed that HMRC had relevant information about her earnings which they passed on to the Authority. In any event her earnings did not increase over and above the minimum wage level apart from the period in 2019 which she has already repaid on the basis that she accepts responsibility for that part of the overpayment. The Authority's letters are lengthy and not clear to follow. Although they do refer to a figure for child care the same letter goes on to say that the figure is ignored in the calculation so she reasonably believed that there was no need for her to do anything further.

- 6. The Tribunal find that the whole of the overpayment arose due to official error to which did not materially contribute and for the above reasons she could not appreciate that there had been an overpayment.
- She accepts that she has reimbursed the overpayment of £845.67 from April 2019 but has repaid a further £589.13 by deduction from her benefit which should be returned to her.
- 8. The appeal is allowed accordingly.

. You had used the same incorrect figure for four years without checking and used a quote to award a childcare cost.

•That I only had minimum wage increase and thought these had been automatically taken into account

·Award letters state based on tax credit figures that are correct so thought award was correct

•As soon as an issue was highlighted I provided everything I had sure it must be an error/mistake •All information provided to you in June and four calculations later still can not get my figures to match your weekly income figures proving how complicated and hard to understand they are.

I would appreciate it if I can now proceed to Tribunal for both Housing Benefit Overpayment and Valuation Tribunal without further delay for hearings as soon as possible. I have looked at my online account and can see a further £1938.00 has been added to my overpayment.

Firstly I want to thank you for dealing with my email submitting the wage slips you asked for so promptly and await the letter explaining the findings. Secondly I would please like it to be known that even if I now can understand and agree the figures I still wish to proceed to Tribunal based on the facts

1)that it was not my error but a department error calculating my award on a wage slip 4 years old - due care and attention not being made. 2)Being unaware that a quote from before I actually moved house had been used for a Child Care Payment being added to my award. No invoice for Childcare ever requested by the department to warrant this being on the award. Child Care Costs not on my Tax Credit Award and those are the figures your letters state my award is based on. Until going through the award letters fully in June had not previously seen the CCP due to finding the figure over complicated/confusing and had trusted them to be correct as the had been based on correct tax credit figures

3)Unaware that minimum wage was not taken automatically into account as is not clearly stated on the letters and this being the only increases I had received for that time period. I have been told by Sarah Wilson it was taken into account and then was stopped. Letters do not state that. I now believe it is being taken into account again due to a friend having an overpayment nt due to a m num wage rise and being told not to

worry it won't happen again as now it is taken into account?? 4)The award letters state based on Tax Credit Figures which are correct and I thought therefore you had all the relevant information. Tax credits informed me you have access to the same system 5) I did not notify you of a change in employer in 2018 due to it not being a beneficial change due to working less hours a week and wages going down not up.

6)That I have been transparent and gave all my information in June and it has now been recalculated at least four times since showing further department error calculating my award. The stress this has caused has been absolutely phenomenal. Yet again I am left extremely stressed awaiting another lengthly document that I am having to go all through, the stress that seeing recovery payments have again started to be retaken as it has been recalculated again and I have to again put in writing why I wish to go to Tribunal. Feeling that I am going around in circles yet again with this whole situation Lastly as I want to still go to Tribunal can recovery for overpayments between 2015-2019 be stopped until it has been to Tribunal as they had been previous to today.

I am aware that £10.92 has been overpaid due to this months wages being slightly more and am happy for that to be deducted as planned

I can see a separate figure of £100.50 has been added to the overpayment and if that for some reason is for this financial year will arrange to clear that in the New Year. With Christmas I am already very overdrawn and can not afford to have £47.20 taken from me on the 2nd as the online account is showing and there after. I am still on reduced wages due to a phased return and still under going further test and have limited mobility.

I have notified the Council Tax Department that I will make payments for this financial year now the bill has been recalculated to show 25% single person discount but as the bills for previous years have a risen due to the error calculating my housing benefit and not my error ask this to be looked at by Tribunal for the same period 2015-1st April 2019.

As soon as the letter arrives I will write with my response and confirm in writing that I still wish to go to Tribunal.

Please can you call me to confirm that only the £10.92 will be taken this month due to still requesting an Oral Hearing at Tribunal as the stress of seeing £47.20 when I am already struggling financially has caused nother panic attack.

I really do appreciate all your help trying to get this sorted and know this is not your fault but I am so tired of it all. I am a hard working, honest single mum and this situation has occurred through no fault of my own, I am going around in circles every month with this and can honestly see why people resort to ending things the stress is ridiculous mentally and financially and I really can't take much more. Thank you for amending the dates for me ask requested in my email to you this morning but I can't see the email I sent this morning asking for this to be done and your response to me in the submission papers as I had also requested.

I see that you have asked this to be struck out before the hearing and in response would also like this email adding to the submission papers too. Whilst I am aware the Council Tax Support is not a benefit the amendments to the the award only arose due to to department error. This has already been determined on a point of law as mention in paragraph five of the decision notice heard at Tribunal in May 20.

Whilst I acknowledge that you are now disputing this and it has been referred back to the judge for clarification at my request would like it noting this was only decided by the department in January 2021 and in the letter from you dated 18/9/20 you did not dispute them and had written them off as not recoverable. Also in the determination the Judge asked for £589.13 to be repaid as this is what my online account showed as being already recovered towards the first two invoices that you are now disputing are covered in his decision. If they were not covered surely the judge would not have included them in his decision. Letter of Further Evidence to the Valuation Tribunal 16/1/2021

Today I have received a summons for council tax even though I had contacted the department on 23rd December asking them to look into the agreement for me and if I could continue to pay £30 a month towards both accounts as I had been. Nobody from the council tax department got back to me to say if this was possible and if not what needed to be done.

I feel it extremely unreasonable that instead of replying to me to discuss this situation they went proceed to issue a court summons even though I had continued to make payments towards these accounts of £30 as previously agreed.

I can no longer cope with the stress that this is causing me and have settled the accounts I believe in full. I have written to the department to ask them to confirm the bill amounts and the amounts paid towards them (Individually listed) and confirm this is now settled in full.

I have asked the £45 admin charge and summons be removed from my record as I had contacted them to resolve the situation and they did not get back to me before issuing the summons. If they are unable to remove this from my records I will attend the court hearing on the 15th February to ask the court if they can remove it. If not I shall pay the £45 but ask if I was successful in my appeal could this be added to the amount they are to repay me as again only arose due to their errors calculating my award.

I have now paid £3380.72 in council tax for the period July 2015- February 2021 and if their adjustments stand and I lose this appeal then the bills have been paid in full.

Should I win this appeal and it be found that due to their errors these adjustments occurred and the Housing Benefit Department are liable for the shortfall in council tax and not myself I ask the original bills are reinstated totalling £1314.54 leaving £2066.18 to be returned to me and the £45 admin fee if I have been made to pay this and the appeal finds this too is due to official error and therefore they are responsible for it and not myself.

I would like to take the time to thank the Tribunal for looking into this matter for me and look forward to their determination so this matter can finally be closed, the stress and anxiety it has all caused me has been phenomenal and look forward it finally being over

To whom it May Concern,

I wrote to the department on the 20/10/2020 asking when £66.10 was added to the xxx account for 2019-2020 as I thought that account was up to date and that I had been making payments of £30 towards the account to for xxxand Bxxx as agreed for the previous years that have arisen since the overpayment in housing benefit.

The agreement for xxxx dated 17/9/20 went up to March 2021 and I believe that xxxx Close is the same.

I received a letter from you dated 9th November 2020 explaining to me that £66.10 was added to the account in March 2020. I therefore cleared the amount of £66.10 on 16th December 2020 and continued to pay £30 each month as I believe this is still under the agreement for the previous years to April 2019.

On the 18th December you issued two final reminders for £204.72 and £18.13 for xxxx Close and I received these on the 23.12.2020 and emailed the department on the same day explaining that I had made payments of £30 to each account as per the agreement plan and asked if this could be looked into for me and asked if the £30 towards the account could continue to be made. Nobody got back to me and I thought that this was still being looked into so again made payments of £30 towards each account at the beginning of January.

Having just reread the letter dated 8th November it mentions a financial statement attached but there was no financial statement enclosed with the letter you sent to me and I thought this was referring only to the £66.10 outstanding which I paid in full as the other amounts were included in the original agreement plan I believe.

I can not find the agreement for xxxx Close but as I was paying £60 originally and it was then split to £30 over each account I thought they were inline with each other and both ended on 1st March 2021 as the agreement dated 17/9/20 showed. If this is incorrect I apologies but nobody has written to me to tell me this is not the case and I did ask for it to be looked into on the 23rd December and am still awaiting your response.

As I have continued to make payments towards these accounts and had written to you on 23rd December and got no response feel it extremely unfair you proceed straight to a court summons without responding to my email 23rd December to discuss the situation and clarify if I could continue to pay £30 and if not explain to me what did need to be done.

I therefore ask that the court summons and additional fee be removed as I had tried to get the situation resolved but you did not respond and I have continued to make payments.

Receiving the court summons today when I believed that the situation was still being looked into having not yet had response to my email dated 23/12/20 was absolutely devasting and it caused so much distress. I am emotionally drained because of all this.

As you are aware I am not currently working and things are tight financially but I can no longer cope with the constant harassment and distress that this is all causing and therefore have settled the amounts owed I believe in full using a credit card and I have the hearing with the Tribunal on 1st March to look at the situation and determine if I am liable for all the adjustments or the housing benefit department as it arose due to their official error calculating the award and the judge determined I played no part in this error.

I have attached a spreadsheet with the total bill amounts and a list of all the payments that I have made and have records of paying. Please can you confirm the bill amounts are correct and that they have been fully paid.

As I have settled the account for xxxx Close and xxxx Close please can the court summons and admin fee come off my records? As I was trying to get this sorted with you but had no response.

This summons will have huge implication to my financial credit score at a time I am already struggling. I had to leave my job in early years due to all the bending and lifting involved that I am unable to do now due to my prolapsed disc and sciatica. I have set up my own childminding business for before and after school care and was hoping to start this in January but due to the schools now being closed have been unable to do so as I am homing schooling my own two children and I am the main carer for my disabled mother and do all her cooking and cleaning during the day too and with her being vulnerable have to be very careful. Hopefully once the schools reopen I can then start this new business.

If you are unable to be removed then I will attend the court date for 15th February to ask the court to decide if it can be removed as I had contacted you on 23rd December asking if the agreement could be looked into and continue and

got no reply and had been making payments and now repaid the full balance. I have been doing my best to stay on top of this situation.

Once you have looked at the payments I have already made and sent me the itemised account of payments you received and given me the total amount due in council tax from 2015-February 2020 if it is more than the £3380.72 already paid then I of course will settle that amount also.

If possible please can this be looked at urgently and a response provided before the 29th January 2021 so that I can add this letter and your response to my submission papers for the Tribunal on the 1st March 2021.

Apologies for all the additional evidence I have submitted since 16th January. I want to show the Tribunal how hard I have been working to understand and resolve the issues with the council tax department. These bills only arose due to the errors made by the housing benefit department and have done my very best to understand the figures and keep on top of the additional payments their error has caused me to face.

Having received the letter from the council tax department on the 18th January I have realised that I had included the wrong bill in my original submission and the bill 11th March 2016 should not be included as it does not reflect the fact I moved house in December 2016 and should in fact be the bill date 13th January 2017 for £121.64 that I have now included and I have amended the figures on the spreadsheet to show these changes.

The letter dated 18th January from the council tax department provided me with their accounts showing what had been paid already and I can now see where my errors were and have also amended these and now agree the amount paid all but a penny. I have the amount as £3384.52 and they have it as £3384.53. since all the adjustments took place the total amount owed is £3380.72 meaning if I am not successful with the appeal I am owed £3.80 which I have asked to be deducted from my next bill. I have written to Sarah Brown today asking her to confirm these figures for me hopefully in time for her response to be added to my submission papers.

Also in the letter dated 18th January I was informed for the first time that I could not continue to make payments of £30 towards the xxxx Close account in line with the agreement plan I have for xxxx Close. This was irrelevant as I had paid both accounts in full the day before but as I was only notified of this on the 18th feel it very unfair they proceeded to a courts summons on the 15th without discussing the situation with me when I had asked for it to be looked into as I believed both agreements ran to the same date.

I am confused why one agreement was allowed to run to March but they tell me the other cannot?

They both arose due to the same error, hence why I thought the dates where the same for both agreements. Surely as they both arose due to the housing benefit departments errors they should both follow the same plan to avoid confusion like it has. It is this confusion and the fact they did not discuss the matter with me and clarify the situation that has lead to a court summons being issued and a £45 admin fee being added to my account. I have written asking for this to be removed as I was not ignoring the situation. I thought both plans followed the same date and continued to make the payments that reflected this had they clarified this with me before proceeding to the court summons I would have made the payment. As I received no response thought it was being looked into and when I received the court summons was in complete shock, it caused so much distress that could have been avoided had the notified me of the situation beforehand. All I had was the final notice that I thought was sent in error as they hadn't updated their records with the £30 paid 30th November and had asked for it to be looked at providing the confirmation email of the payment

As I have been doing all I can to understand and resolve this and had asked for clarification before they applied for the summons but had no response until the 18th after they had already requested it feel that the £45 admin fee and court summons should be removed as I am again being punished when I was trying to get it sorted. I am also left concerned that this will have now impacted on my credit rating at an already very difficult time again feel this occurred through no fault of my own but from the lack of communication explaining to me the situation from the council tax department. Had I received the letter dated 18.1.21 beforehand I would have been able to make the payment intime and avoided this further stressful situation. I have asked Sarah Brown to inform me if this can be removed and if she can let me know before 25th January so her response can be added to my submission papers for this Tribunal.

If I am successful with my appeal and the original bills can be reinstated due to the arrears being down to the housing benefits department and therefore they are responsible I am asking that £2138.08 be returned to me. The original bills equal £1246.44 and I have now paid £3384.52. I have again asked Sarah Brown to confirm these figures

by 29.1.21 so I can add her response to my submission papers and highlight/resolve any discrepancies before the hearing.

If I am successful with my appeal and have been made to pay the £45 admin fee I ask that this is also returned as again feel this was unfairly added due to them not informing me of the situation before proceeding.

I look forward to this all being decided by the Tribunal as I can not express how stressful it has been for me since their errors came to light in June 2019 which then has caused all these further problems resulting in this Tribunal too. I feel I have had to battle constantly when it was not my fault they occurred in the first place. When you are trying to do your best in a bad situation that you did not cause and get nowhere with them and everything is made so complicated that it is confusing and so difficult to understand it is soul destroying and I am not sure that the council appreciate the devastation they have caused. I fail to understand why it has to be so complicated why both agreements couldn't be the same and why they could call to talk me through this and explain the situation avoiding the court summons in the first place. I had said all along I wished to make regular payments up until the hearing and would then pay the remaining balance once it was heard if the appeal was unsuccessful this would have made things much less stressful. They have made a difficult situation even harder. Surely some common sense and compassion should be applied and support for people that are doing their best in a very bad situation that arose due to no fault of their own. I really can see why people get into such a mess and see no way out. It has been a complete nightmare all the way through and look forward to the situation finally being resolved

Firstly apologies for the many emails sent over the weekend since receiving the court summons, I have been working tirelessly to understand and hopefully resolve the situation.

Yesterday I received a letter from the department in response to the email I sent on the 4th January 2021. I appreciate that you are very busy and from this letter I received yesterday it seems my emails from the weekend have not yet been looked at. I am hoping that as this one is marked for your urgent attention that it reaches you soon as it superseded the others I have sent to some extent as I can now get my figures to match yours on what has already been paid thanks to Mr Jarvis's letter dated 18.1.21. Please do thank him for sending me the information I had requested as it really help me understand what had been paid and I can now see the refund of £177.55.

In my original submission to the tribunal I had submitted the wrong original bill from 2016 – 2017. I had sent the one from xxxx that started in April 2016 and went up to March 2017 for £189.74 rather than the adjusted one due to me moving house for £121.64 dated 13.1.2017 that does show the refund. As I had not originally submitted this bill could only see the refund added to recent bills and therefore was confused as to when it was issued. I have no corrected my error and can as I say see it was paid and I have sent in the correct bill to the tribunal from 13.1.2017.

As Mr Jarvis sent me the information requested and I have amended my errors I now get my figures for the amount paid to tally all put a penny. The amount paid so far being £3384.52 according to my figures and £3384.53 according to your own figures.

Totalling £1246.44 this the total amount I needed to pay at the time after the singles personal deduction and council tax support as it was originally calculated. Please can you confirm if I have the correct figures? If this could be done before the 29.1.2021 to be added to my tribunal submission papers I would be extremely grateful. If my figures are incorrect I would be grateful if you could provide me with a copy of the figures you have, again for the Tribunal appeal.

Lastly please can the £45 admin fee and court summons be removed?

I honestly believed the agreement plan for xxxx Close was inline with the agreement for xxxx Close paying £30 a month up until February 2021 and the remaining in March 2021. Having now received the letter from Mr Jarvis dated 18.1.21 it seems this is not the case. I had written to you on 23.12.21 after receiving the final notice as I was

confused to why it had been issued as I had made the £30 payment that I believed was inline with the agreement asking one if it could be looked into and if I could continue doing so until March as I was doing with xxxx Close.

I was only informed in the letter dated 18.1.21 that I could not do so, had the department contacted me before this to explain the situation then I would have of course made the payment and avoided the court summons as admin charge. As I had contacted you to get this looked at I had thought this is what was happening so made a further payment of £30 in January.

As I was not informed of the situation until 18.1.21 and the court summons was issued on 15th January 2021 feel that was extremely unfair as I was not ignoring the situation and had asked for clarification and continued to make payments. I have tried to keep on top of the situation the best I can. It has been so stressful and confusing and these additions arose through no fault of my own as a judge has already determined the housing benefit department are responsible for the errors that caused the overpayment in housing benefit which in turn is what caused the incorrect council tax support award and the huge increases in my previous years council tax bills.

As I was trying to keep on top of things and had written to you feel it unfair it proceeded to a court summons without anyone contacting me about it first. If it had been explained to me that it was not actually inline with the xxxx Close agreement for some reason and that the full amount was due in December I presume and not March as I had thought I would have asked my mum for the money and made the payment. It is because I was not made aware before you issued the court summons that I ask for the £45 fee and court summons be removed.

I believed that this was being looked into and was awaiting your response so when I received the court summons on 16th January I was in complete shock and the distress it has caused has been phenomenal . it is this distress that has seen me take a money transfer on a credit card to clear both accounts as I really can not take much more.

Please can you again confirm if the fee and summons can be removed as I was trying to get this resolved before you proceed to issue the summons. Please can I have confirmation before 29.1.21 again so it can be added to my submission papers for my appeal on 1st March 2021.

Thank you for your time and I hope to hear from you soon to get this matter resolved before the hearing date.

In response to the letter received today from the council tax department.

This email still does not provide the figures I requested. I did receive figures on 18/1/21 but it did not include the payments made from 16/1/21.

They have also not confirmed for me the total amount owed since the amendments in council tax support and the total bill amount before the amendments

This letter states the agreement had been cancelled in October due to not making payment in line with the agreement. I did email when this happened to show the payment had been made and had continued to make the payments in line with the agreement and when I received the final reminder in December wrote again to say I had been making payments in line with the agreement.

This was not looked into for me as requested which resulted in the court summons being issued.

Again I had done nothing wrong and had not missed any payments as I had proved by sending screen shots proving the payment had in fact been made.

As this was not looked into when requested and went instead straight to a court summons I have been caused even more distress through not fault of my own but yet another department error.

This stress causing me to clear the outstanding balance on a credit card as I just can not cope with having to deal with them any further.

I feel the way I have been treated since the housing benefit department error was discovered and my bills have been adjusted has been disgusting. It was due to no fault of my own this arose and rather than being given support trying to keep on top of the bulls caused by official department error. I have been hounded . This stress caused has been unbelievable . Over four years worth of bills expected to be cleared straight away when it was caused through no fault of my own is unfair and when a plan was put in place they cancelled it even when I had on fact made those payments.

I feel it extremely unfair department error left me with these bills in the first place and then I have done all I can to resolve the situation and they made further errors that then saw my plan cancelled through no fault of my own.

From their letter I believe they have at least removed the £45 admin fees added due to the courts summons

The distress all this has caused has been overwhelming and I see this is trying to be struck out before hearing which again I feel is so unfair. Why is it department errors can leave innocent people facing not only huge bill but constant harassment and unbelievable amounts of stress?

I hope this can proceed to hearing and be determined fairly.

I have just received a letter to state that £66.10 is due for the above account from April 2019-February 2020. As far as I was aware this period was up to date please can you advise me of when this extra amount was added to the account and why?

Also at the moment I am not currently working so don't have £66.10 to hand to be able to pay this on the 23rd October as your letter asks.

I have been making payments at the beginning of each month of $\pounds 30$ as agreed in my instalment plan and also $\pounds 30$ towards 73969548 as I have not missed a payment have stayed within the agreement ask that this is looked into.

I have attached two photo's showing my last two payments. In the first you will see that I accidentally used my current account number twice rather than the account number above for Heron. I presumed as I submitted the correct address just the wrong account number that it would still be paid off the correct account.

When I realised the extra £30 had come off my other account you can see the next payment was for £60 to rectify the previous months error.

As I have done my best to keep up to date with this agreement even when I am not working hope that the instalment plan can be continued until this goes to Tribunal and the extra £66.10 added to the agreement ?

I have also emailed the benefit department as they have awarded me £1.83 based on my previous wage slip even though I notified them that the claim is due to me not working. I stopped working on the 18th September and the new claim was from the 28th September so this also needs looking into and recalculating as my current bill is also incorrect.

I will contact my local MP on the 28th October if I haven't heard from the benefit department as this is 15 working days after I emailed for the second time apart the issue.
